One nabbed for double murder

The Dhoomanganj police claimed to have arrested Akbar in connection with the sensational double murder of the Mariadih village head, Abid's sister, Alkama, and their driver, Surjeet, in September 2015. Akbar is also an accused in the murder of the BSP MLA, Raju Pal, which took place in the year 2005. The arrest was made after re-investigation of the murder case and it is expected that some other persons, including Abid, would also be arrested soon. The re-investigation was done after Surjeet's wife had approached the court alleging that the accused named in the FIR were innocent.

It may be pointed out here that Mariadih village head Abid's sister, Alkama, and their driver, Surjeet, were gunned down on the night on September 26, 2015, while she was coming to the village for celebrating Bakrid. Their bullet-ridden bodies were found in the SUV. Sensation had prevailed in the area as Abid was said to be close to the former MP, Atique Ahmad, and also an accused in the Raju Pal murder case. Abid and his supporters alleged that the assassins had tackled his SUV to kill him instead Alkama and Surjeet were gunned down. On the complaint of Abid, a case was registered against Intikhab Alam, Tauseef, Kammu, Zahir, Aseem, Maqsood and Sabir. However, the accused claimed innocence and evaded arrest.
