deduction of 100 per cent in
respect of emoluments paid to
eligible new employees who
had been employed for a min-
imum period of 240 days dur-
ing the year under Section 80-
JJAA of the Income-tax Act.
He said however, the min-
imum period of employment
was relaxed to 150 days in the
case of apparel industry. He
said in order to encourage cre-
ation of new employment it
was proposed to extend this
relaxation to footwear and
leather industry. He said fur-
ther it was proposed to ratio-
nalise this deduction of 30 per
cent by allowing the benefit
for a new employee who was
employed for less than the
minimum period during the
first year but continued to
remain employed for the min-

imum period in subsequent
year.
