

In a bizarre incident, activists of Shiv Sena hoisted the national flag amidst firing in the air at their office in Gujaini locality, under the Govind Nagar police station on Tuesday morning. After firing, they said 'Yeh Azadi Ke Jashn Ka Mahaul Hai' hereafter, district chief of Shiv Sena Arun Sharma unfurled the flag. It may be recalled that the office of Shiv Sena is situated in Gujaini, Govind Nagar. Its district chief Arun Sharma was usually caught in controversy over different petty issues. During the assembly elections, he had filed his nomination which was later cancelled by the authorities. Speaking on the occasion, Arun Sharma said 15th August was the historical day when the country got freedom. On this occasion, a flag hoisting ceremony was organised at the office of Shiv Sena. As all the countrymen had fought for the freedom for their country, they would also put in their efforts to end corruption. A rally would soon be taken out to spread message of unity, he added. However, he dilly dallied on the issue about firing during flag hoisting. SP (South) Ashok Kumar Verma feigned ignorance about the firing during flag hoisting as he was busy in controlling a rally. However, he admitted to have heard about the incident and if it was the fact, penal action would be initiated against the guilty, he added.

YOUTH KILLED IN FIELD: In a daylight incident, a youth was killed in a field, under the Sheoli Kotwali police station of Kanpur Dehat on Tuesday afternoon. Rasoolabad Circle Officer along with Kotwali Inspector Radha Mohan Dwivedi and force reached the spot and carried out investigations. The body was lying in the field with deep injury on his head. It was apprehended that assailants killed him with any heavy object. The deceased was identified as Shailendra (24), resident of Sheoli. Family members informed that Shailendra had gone to field in the afternoon and after some time, villagers informed about his lying dead there. After the incident, tension prevailed in the village while police claimed to work out the case soon. The body was sent for autopsy.

INJURED: In a tragic incident, two children sustained minor burns when a school Van (UP78 AM3856) suddenly caught fire due to electric short circuit, under the Kidwai Nagar police station on Wednesday morning. Four other children present in the same van were safely rescued. According to reports, when a van of Standard Model School, Saket Nagar, was going to collect children from Govardhan Purwa, Kidwai Nagar, it suddenly caught fire due to electric short circuit. With the help of local residents, all the children were rescued. However, two students sustained minor burns who, after the first aid, were sent to home.

Suicide

KANPUR: A newly-wedded couple committed suicide by hanging themselves in Sunhala village, under the Maharajpur police station on Monday night. Two days ago only, the brother of the woman was killed in a road mishap when she had gone to her parents house. She had returned from there with husband on Monday itself. Police held personal dispute between the couple led their killing. The marriage of Pankaj Sahu (22), elder son of farmer Tej Narain Sahu of Sunhala village was held with Pinki (20) daughter of Dwarika, resident of Kadra village of Aung (Fatehpur) on June 18. On Monday night, both were found hanged. At the time of incident, Tej Narain along with wife Savitri and daughter Nanki was in the field. On return, when they failed to get any response, they entered the house through the roof and found the couple hanged.
