

वहीं 15 गांवों से संपर्क टूट गया है। बचाव कार्य के लिए एनडीआरएफ के जवानों को लगाया गया है और पुलिस को अलर्ट मोड पर रखा गया है। जिला अधिकारी के अनुसार बचाव और राहत कार्य युद्धस्तर पर जारी है। अपर जिलाधिकारी शिव प्रताप शुक्ला ने बताया कि इस समय गंगा का जलस्तर 78 मीटर से अधिक हो गया है।

उन्होंने बताया कि सदर तहसील के हरसिगपुर मुजेहरा कलां तीलटी सेमरा मल्सलेपुर भोगांव, बल्लोीपरवा, मडिहगांवा, मटिया सहित 98 गांव बाढ़ की चपेट में हैं। इसी तरह चुनार तहसील के धनैता, समसपुर,

पसियाही, गांगपुर, धन्नुपुर, सरेया, शिवपुर कादियां सहित 85 गांव बाढ़ की विभीषिका झेल रहे हैं। उन्होंने बताया कि बाढ़ प्रभावित गांवों में बचाव और राहत कार्य के लिए 42 नावों और 9 मोटर बोट को लगाया गया है। दो दर्जन से अधिक राहत केंद्र बनाए गए हैं। साथ ही गांव के लोगों को सुरक्षित स्थानों पर पहुंचाया जा रहा है। वहीं पशुओं को भी सुरक्षित स्थान पर बाड़े में रखा जा रहा है।

अपर जिलाधिकारी के अनुसार बाढ़ प्रभावित क्षेत्रों में राहत पैकेट बांटे जा रहे हैं। जिलाधिकारी प्रवीण कुमार लक्षकार ने बताया कि जिले में सी से अधिक गांवों में फसलों को भारी नुकसान पहुंचा है।

फसलों की क्षति के आंकलन के लिए लेखपालों को लगाया गया है। उन्होंने बताया कि जिले के अधिक प्रभावित गांवों से लोगों को निकाल कर सुरक्षित स्थानों पर पहुंचाया जा चुका है। जिलाधिकारी ने बताया कि कंट्रोल रूम भी स्थापित किया गया है।

देश को महंगाई तले रौंद रही है केंद्र सरकार : कांग्रेस

कांग्रेस ने केंद्र सरकार पर देश को महंगाई तले रौंदने का आरोप लगाते हुए सोमवार को कहा कि इस ‘सरकार का पिछले आठ वर्षों का रिकार्ड इस सच्चाई को उजागर’ करता है।

कांग्रेस की राष्ट्रीय प्रवक्ता सुप्रिया श्रीनेत ने यहां संवाददाता सम्मेलन में देश में महंगाई और बेरोजगारी के मुद्दों का जिक्र करते हुए कहा कि आज की कहानी पीपली लाइव के

गाने में संशोधन के साथ है – सखी सैया तो नईखे (नहीं) कमात हैं, महंगाई डायन मारे जात है।”

उन्होंने दावा किया, ‘प्रधानमंत्री विपक्ष में रह कर बहुत बड़ी-बड़ी बात करते थे मगर आज उन्होंने ही जनता को महंगाई के बोझ तले दबा दिया है। आज जब 45 वर्षों में सबसे अधिक बेरोजगारी है और आय घट गई है तब देश को महंगाई तले रौंदा जा रहा है। पिछले आठ वर्षों में मोदी सरकार का रिकार्ड इस सच्चाई को उजागर करता है।
